THE Filmmaker IS RELEASED OF LIABILITY: For good and valuable consideration herein acknowledged as received, the Subject releases the Filmmaker and assigns permission to license all images and sound recordings and to use of images and sound recordings in any media for any purpose which may include, among others, advertising, promotion, marketing and packaging for any product or service. The Subject agrees that any images and sound recordings may be combined with other images, text and graphics, cropped, altered and modified. The Subject agrees that the Filmmaker has no duty to show the Subject any material prior to using or distributing the material in any form.

2. THE Filmmaker RETAINS ALL RIGHTS: The Subject agrees that the Filmmaker has all rights to images and sound recordings, for perpetuity unless explicitly noted in this Agreement. The Subject acknowledges and agrees that the Filmmaker is not liable for any further consideration or accounting, and further claims for any reason.

3. DURATION OF AGREEMENT: This Agreement is binding on all heirs, legal representatives, and assigns of the parties to this Agreement. The Subject acknowledges and agrees that this Agreement is irrevocable, worldwide and perpetual.
